## **KEEP IN TOUCH WITH THE ASSOCIATION OF CONSULTING ENGINEERS, SRI LANKA**

### **COUNCIL MEETING**

The new council elected in Jan'04 has been meeting monthly for the committee meetings and in addition have met every fortnight in between in order to finalise the following:

1. Draft new Rules for ACESL
2. Revision of Fees Structure
3. Organise Seminar in Sept'04

The council has sent congratulatory messages for the Prime Minister & a few other Ministers relevant to the Consultancy Industry wishing them success and extending our fullest cooperation in the activities. The Pri Minister & other Ministers have responded with immediate replies .

The Council has taken action to inform the Sri Lanka representatives of the World Bank , Asian Development Bank, JICA & Heads of Departments, Boards, Corporations, ICTAD and IESL with regard to the incorporation of ACESL in order to build up a close liaison & effective dialogue on matters concerning the industry.

A delegation from the ACESL met the IESL Council to discuss our concern with " the registration of the Consultants". ACESL council was of the opinion that engineering consultancy is a matter for the ACESL.

The council wishes to bring to the notice of our members & the Member Firms the ever increasing costs the council has to meet annually. FIDIC Annual subscriptions is costing Rs 10,000.00 more annually in view of the foreign exchange. More than 60% of the Membership fees is spent to pay above & CCI membership. With the incorporation the council has to have our records in order and have decided to build up our assets with the purchase of cupboards etc. One day very soon, we will have to have our own office to manage the affairs. Our efforts to find a convenient and an affordable place have not succeeded as yet.

TCDPAP which have been inviting the ACESL to join as Member, we not been able to meet the costs has prevented us joining in. In spite the TCDPAP have been inviting two of our Members to participate at their AGM's. So the council is planning to explore other means of finances for funding. The council is forced to increase the Membership Fees as from this year and the proposals would be framed & included in the New rules for ratification at a Special General Meeting in August'04. The Council wishes to invite special Donations in this aspect from our highly reputed Members & Member Firms who could afford to join in this venture to build up the Association.

### **FIDICS Code of ETHICS**

- Responsibility to society and the consulting industry
- Competence
- Integrity
- Impartiality
- Fairness to others
- Corruptions

"**Corruption**" is defined by Transparency International as:

**" The abuse of Power to achieve a personal gain"**

**Integrity** means safe business.

In 1999, as a fundamental issue of capacity building, FIDIC proposed to develop a system for managing integrity.

FIDIC recommends that :

Member Firms must have a commitment to integrity through the implementation of an " Integrity Management system" involving all levels of management and every employee.

### The Concept of Integrity Management

The Integrity management concept calls for an internal system of the consulting firm, designed as an effective tool to prevent corrupt behavior and to encourage integrity.

### The Integrity Management "**check list**"

1. Management Responsibility
2. Organisational responsibility and authority
3. Resources and Personnel
4. Integrity Management Processes
5. Integrity records
6. Feedback
